





<u>From:</u> Marshall Nau – Southern Marin Fire Protection District (SMFD)

Fire Inspector – "Southern Marin Emergency Notification Network" Lead

<u>Subject:</u> Use of TCSD controlled/owned property for the installation of critical outdoor emergency notification sirens. Areas to be served would be Eastwood Park and Marin View.

<u>Summary:</u> The SMFD has been working with local municipalities to install additional outdoor emergency sirens in the southern region of Marin County. There are currently 12 sirens installed in Mill Valley, Sausalito, Tiburon, Strawberry, Homestead, and Tam Valley. The one located in Tam Valley is on the Poplar fire station #4 and provides coverage to the main valley from near Tam Junction to the SE portions of Northern. The Fire District has identified two areas of Tam Valley that would benefit from future siren locations. One in the Marin View area and the other in the area of Eastwood Park. The technology used for this alerting system is known as LRAD and provides sirens and voice communications. This was presented to the TCSD Board of Directors in 2022 along with a fire weather outlook for the 2022 fire season.

Recommendation: It is the current recommendation of the SMFD to proceed forward with the drafting of a resolution that would stipulate the permissions required by TCSD to have SMFD install a standalone pole structure at each site, not to exceed a specified height, with a siren and solar components attached. Similar resolutions have been completed with the City of Mill Valley and the City of Sausalito. Both are provided for review.
